#### 3:30 P.M. CALL MEETING TO ORDER:

Chair Inscore called the meeting to order in regular session at 3:30 P.M. Roll was taken with all the commissioners present as indicated.

#### **PLEDGE OF ALLEGIANCE:**

The pledge of Allegiance was led by Commissioner Cowan.

#### **PUBLIC COMMENTS:**

At 3:31 P.M. Chair Inscore called for public comments, seeing none the Chair then closed the public comment period.

Director Ward requested two items to be added to the agenda as urgency items. Both items arose subsequent to the posting of the agenda on 13 October 2017. The first item was an invoice that was not received before the agenda was published, but payment of this claim requires Board approval. Regarding the second item, it was not

known until October 17<sup>th</sup> that negotiations for the processing agreement would not be complete.

Both items require action before the next meeting as for the first approval of payment is needed to avoid late penalties. And for the second without the adoption of change order 14 extending the temporary waiver, Recology would be in violation of contract provisions requiring that they have a processing agreement.
